- 2. Motion made by Mr. Rogers, seconded by Mr. Walters and a unanimous vote, Council approved the Danville Borough Fire Police's assistance with traffic control on June 8th in Turbotville for their Community Parade.
- 3. Motion by Mr. Walters, seconded by Mr. Rogers and a unanimous vote, Council approved Jim Strader-Sasser's request for use of the area around the Christ Memorial Episcopal Church on May 5th from 9 AM to 5 PM and May 6th from 9 AM to 1 PM. No streets to be closed.
- 4. Motion by Mr. Rogers, seconded by Mr. Walters and a unanimous vote, Council has approved Amendment #1 to Subgrantee Agreement between the Borough of Danville and Danville Little League. This allows the 2015 CDBG parking lot project to be extended past the original deadline of April 29th to June 1st.
- 5. Cooperative Agreement between the Borough of Danville and Danville Little League to authorize spending of 2016 CDBG allocation of \$5,200 previously reallocated by Council was approved on a motion by Mr. Herritt, seconded by Mr. Walters.
- 6. Ordinance No. 548 prohibiting parking on sections of Spring Street has been advertised and ready for adoption at the April 10th meeting.
- 7. Ordinance No. 550 providing 15 minute parking on Nassau Street has been advertised and ready for adoption at the April 10th meeting.

10. Resolution 2018-5 – approving the sale of 453 Mill St., was approved by Mr. Rogers, seconded by Mr. Woodruff and a unanimous vote.
