Minutes  
October 1, 2019

Danville Borough Council held a meeting on Tuesday, October 1, 2019 at the Borough Building, 463 Mill St., Danville at 6:00 PM. President Herritt presided.

Present were Councilpersons, Walters, Rodman, Woodruff, Herritt, Walter, Beers, Gregg and Stigerwalt. Also present were Mayor Swank, J. Hart, B. Earlston, B Horne, S. Berkey, Chief Gill and J. Graham.

The invocation was given by President Herritt followed with the Pledge of Allegiance to the Flag.

1. Ms. Donna Dietz attended with a complaint on the construction project with the levee, referring to the hours of work. Construction was going on before 6:00 AM. She asks that Council consider not letting this take place again.

3. Motion by Mr. Walters, seconded by Mr. Stigerwalt and a unanimous vote, Council approved Trick or Treat night to be Thursday, October 31<sup>st</sup> from 6-9 PM.
4. The Columbia-Montour Visitors Bureau is requesting up to nine Fire Police for the Covered Bridge Festival at Knoebels Amusement Resort on October 5, 2019. Motion by Mr. Stigerwalt, seconded by Mr. Woodruff and a unanimous vote, Council approved this request.
5. Motion from Mr. Stigerwalt, seconded by Mr. Rodman and a unanimous vote, Council approved a request from Scott’s Floral for Cole’s Alley (from Pine St. to Ferry St.) to be posted “No Thru Traffic” on the Ferry Street end on October 5<sup>th</sup> from noon to 8PM for Karen Gronsky School of Dance to hold a dance fundraising event.
6. Ordinance No. 559 will be ready for adoption on October 8<sup>th</sup> to borrow \$800,000 for the completion of the levee raising project.


