Danville Borough Council held a meeting on Tuesday, November 6, 2018 at the Borough Building, 463 Mill St., Danville at 6:00 PM. President Richardson presided.

1. Motion by Mr. Walters, seconded by Mr. Walter and a unanimous vote, council approved of Resolution 2018-14 to Adopted Mahoning Township’s updated Act 537 plan pertaining to the sale of the sewage conveyance system to Suez.
 2. Motion by Mr. Stigerwalt, seconded by Mr. Rodman and a unanimous vote, council gave the staff approval to solicit RFP’s for a loan for the new police station.
 3. 2019 Budget – preliminary adoption will take place next Tuesday
 4. Motion by Mr. Walters, seconded by Mr. Stigerwalt and a unanimous vote, Council approved the subdivision for the Front Street lot for the new police station that was previously approved by the Planning Commission.


News Media.....President Richardson
